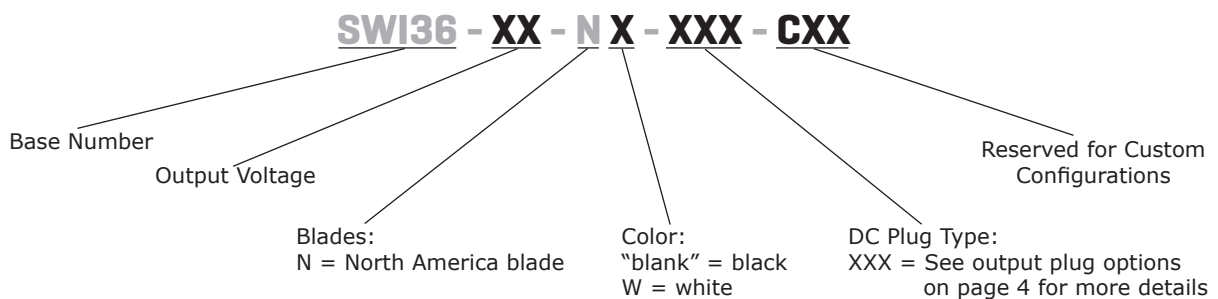

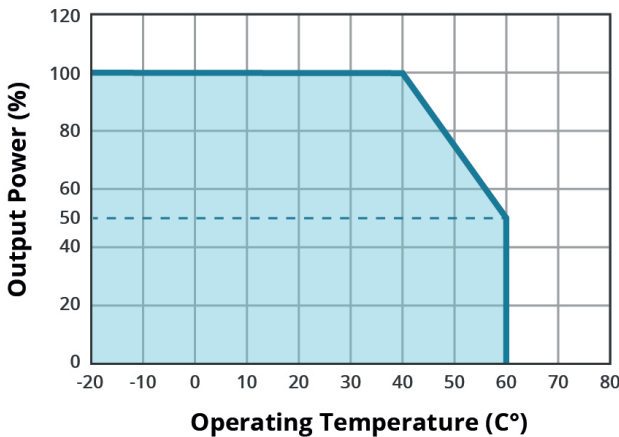

TEMPERATURE DERATING CURVE

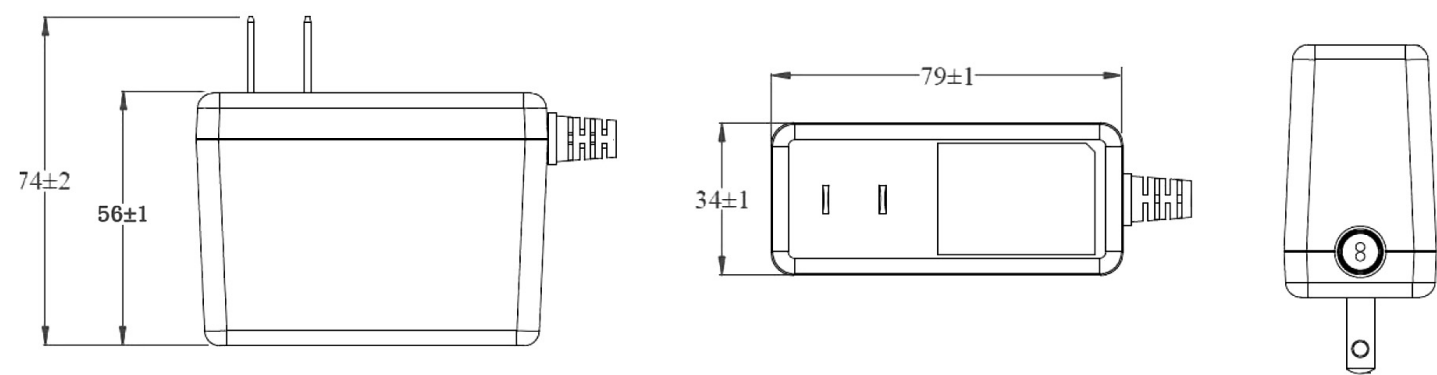
